<b>Match Results Only Via Web</b>	<b>Match results are due within three days and may only be posted via the web - (<a href="http://www.phillyboast.org">www.phillyboast.org</a>). Tab to Interclub League and click on the results form.</b>
<b>Start Time / Rescheduling</b>	Start time is 6:30, but clubs may vary 30 to 45 min. Contact the host captain to confirm. Matches may only be rescheduled for inclement weather, must be rescheduled and played within 7 days.
<b>Schedules / Attire</b>	Schedules are created on the basis of one team playing a league match on one court. Reminder / Attire: almost all clubs require white clothing for play.
